**YEARLY LIABILITY WAIVER**

1. **Voluntary Participation.** I agree that I, the undersigned, do for myself or on behalf of my child, spouse, or legal ward, hereby voluntarily participate in the events and that I/we participate in the events totally at our own risk for injuries or property damage we may incur in relation to events.
2. **Incident Costs Responsibility and Medical Insurance Disclosure.** I agree that I/we will be responsible for any and all costs incurred by us for injuries or property damage I/we incur and that I/we are covered by accident-medial insurance coverage now in force.
3. **Personal Responsibility.** I agree that I am responsible for the negligent acts of mine, my family members and/or legal wards and animals, and do carry personal liability insurance now in force.
4. **Personal Financial Losses.** I agree that I am responsible for my own financial loss in relation to the theft or damage to our tack, equipment, vehicles, trailers and horses while on the premises where events are held.
5. **Protective Headgear Warning.** I agree that I have been fully warned and advised by this club that I should purchase and wear protective headgear which meets or exceeds the quality standards of the SEI CERTIFIED ASTM STANDARD F 1163 Equestrian Helmet, while riding, driving, being and working near horses. I understand that the wearing of such headgear may reduce severity of some of the wearer's head injuries and possibly prevent the wearer's death from happening as the result of a fall or other occurrences.
6. **Liability Release.** I agree that I hereby, for myself, my family members, my heirs, administrators, personal representatives, and assigns, do agree to hold harmless, release and discharge this club, its owners, agents, employees, officers, directors, representatives, assigns, members, premise owners, affiliated organizations, insurers, and others acting on its behalf, of all claims, demands, causes of action, and legal liability, whether the same be known or unknown, anticipated or unanticipated due to this club's ordinary negligence; and I do further agree that except in the event of this club's gross negligence, I shall bring no claims, demands, legal actions and causes of action against this club and its associates as stated above in this clause for any economic and non-economic losses due to bodily injury, death, property damage, sustained by me and/or my minor child or legal ward in relation to the premises and operations of this club, to include but not limited to, while riding, driving, handling or otherwise being near horses or other equine species.

**\*Coggins\*** The undersigned states that he/she is in possession of a negative Coggins test for the horse or horses that are at the event and that test was drawn within the last 12 months.

**\*Rides\*** I understand that there are to be no rides given to the public, and understand that if I, my group, or family were to do so that I/we would take total responsibility upon myself, my group, or family for any injuries caused as a result of giving rides and I/we would hold harmless the Manes & Tails Harness Club, Inc. and any of their officers, directors, employees, agents and volunteers.

**\*Safety\*** I understand that if I use unsafe harnesses, vehicle, hookup or exhibit unsafe driving practices (i.e. cantering, unsafe passing, etc) that could endanger myself or others, I will be asked to leave.

**\*Youthful Drivers\*** Youthful drivers under the age of 14 must be accompanied by a knowledgeable adult horseman *in the vehicle* at all times as per American Driving Society Rules.
